1. Vendor Question: What security platform is being used currently at UCF that would be involved in this project?

UCF Answer: UCF uses Active Directory and is beginning implementation of SailPoint IAM.

2. Vendor Question: Is there documentation that can be shared on the policies and guidelines that would be expected to be followed in the project?

UCF Answer: UCF Policies can be found at <u>https://policies.ucf.edu/;</u> <i>UCF IT policies can be found at: <u>https://policies.ucf.edu/#ucfTechandComm</u>. Additional requirements will be included as part of project planning.

3. Vendor Question: What are UCF's current governance polices related to the project?

UCF Answer: Please see answer to question #2.

4. Vendor Question: What other tools outside of Tableau, Excel and PowerBI could potentially be in scope for integration within the project?

UCF Answer: Tools such as SAS and SAS Visual Analytics are among the additional tools that could be integrated.

5. Vendor Question: What format is the historical data in? Structured data in databases, unstructured, semistructured, files?

UCF Answer: The historical data is contained in Oracle databases.

6. Vendor Question: In Section 4.1 1 (c), does the University have preference for specific reporting tools?

UCF Answer: No, this is dependent on use case, best fit, and best practices for the report identified.

7. Vendor Question: In Section 4.1 what are the sizes of PeopleSoft databases? How much data is expected to be in the data lake?

UCF Answer: Total size could range from 3TB - 6TB of data ingested into the Lake. PeopleSoft is on-prem on Oracle databases. Additional data to be ingested to be determined based on priority use cases in Phase 2.



8. Vendor Question: In Section 4.1 are there existing APIs to extract data from UCF applications OR will this have to be built?

UCF Answer: API capabilities will be assessed and determined when the use case of the data source is identified.

9. Vendor Question: Please provide a list of applications that are expected to consume data from this data warehouse.

UCF Answer: Applications, other than reporting tools, needing to consume data will be identified based on selected use cases for data ingestion.

10. Vendor Question: Would the data be loaded in the warehouse as a stream or in a batch process or both?

UCF Answer: Determined by data and use case.

11. Vendor Question: Are there any third-party dependencies like external service providers that this solution must work with?

UCF Answer: The new Data Governance tool which UCF is currently in the process of procuring. There may be others as project develops.

12. Vendor Question: Do you have any other data sources apart from Workday and PeopleSoft? If yes, Please specify the data sources?

UCF Answer: There are several data sources that are planned to become part of the environment, but for Phase 1, the focus will be on historical PeopleSoft data; Phase 2 will incorporate additional data sources based on prioritization of use cases.

13. Vendor Question: What is the data size of the existing data sources? Where are the existing data source systems hosted? (Cloud/on-prem/hybrid)

UCF Answer: Please see answer to question #7

14. Vendor Question: For each source system, what is the format of the backend database? (SQL, MS Access, Oracle, etc.) What would be the average growth of data per year?

UCF Answer: PeopleSoft for Phase 1 is on Oracle. Other data sources span different backends depending on which are identified and prioritized for conversion.



15. Vendor Question: What is the estimated number of End-users? Also, please specify the user roles.

UCF Answer: Yet to be determined.

16. Vendor Question: Do you have templates for the list of reports that you would like to produce from the data warehouse/Data Lake?

UCF Answer: Yes, for some, others will be built as needed.

17. Vendor Question: What is the minimum data refresh rate required (daily/weekly/monthly/hourly/real-time)?

UCF Answer: To be determined, based on use case. We are not anticipating needing real-time refreshes.

18. Vendor Question: Is disaster recovery required for the data warehouse? If yes, what is the backup retention policy?

UCF Answer: Yes, there will need to be a disaster recovery plan put in place. The Retention policy for the environment is to be determined.

19. Vendor Question: Can we assume that UCF will provide us the Development, Testing, and Production environment?

UCF Answer: The selected vendor may have to provision those environments within our Azure space.

20. Vendor Question: Is it mandatory that the vendor should provide references in Higher Education or the public/government entities' reference is enough?

UCF Answer: UCF is a state public university, so references in the education sector are preferred; however, relevant public entity/state government experience could be considered.

21. Vendor Question: What is the implementation timeline for Phase 2 & 3?

UCF Answer: Dependent on Phase 1 completion but to start sequentially immediately thereafter; planning may begin prior to completion of Phase 1.

22. Vendor Question: Can you please specify the budget cap that we need to consider?



UCF Answer: Not at this time.

23. Vendor Question: Can we utilize a hybrid resource model (on-site, remote, offshore) to accomplish this project?

UCF Answer: Please see answer to question below.

24. Vendor Question: Can the work be performed remotely, or do you expect the vendor to perform the tasks on-site?

UCF Answer: At this time, we are planning for much of the work to be completed virtually. However, as the project progresses, there may be a need for limited on-site work, which will be identified and planned out.

Section 2.42 & 3.2D.3 Travel Expenses Section 2.42 indicates....

The Respondent shall not under this ITN or any resulting contract charge UCF for any travel expenses, meals, and lodging without UCF's prior written approval. UCF Answer: UCF's written approval must be received prior to incurring travel expenses in accordance with Section 112.061, Florida Statutes and applicable UCF policies.

Vendor Question: Section 2.48 Work for Hire: Would UCF consider granting the vendor limited future use of the designs, prints, paintings, artwork, sketches, etchings, drawings, writings, photographs, or any other work or material or property produced, IP as opposed to a full work for hire clause?

UCF Answer: No

27. Vendor Question: Section 4.2 Consultant Responsibilities & Deliverables: Is the expectation that all work will be complete in and data retained in the UCF licensed and controlled Azure Resources?



UCF Answer: Yes.

28. Vendor Question: Section 4.1 Implementation Phases & Timeline: Are there specific historical PeopleSoft modules that are in/out scope for Phase 1.

a. If there are PeopleSoft modules out of scope for Phase 1, do these modules become part of scope for Phase 2 or 3?

UCF Answer: Modules in and out of scope will be determined during project planning

UCF Answer: Workday datasets and methodology to be used yet to be determined; actual ingestion of Workday data will be part of Phase 2. Creation of custom reports in Workday is not in scope for this project.

- a. How many large-scale data use cases are anticipated?

UCF Answer: Some have been identified and prioritized; the Phase 2 use cases will be finalized during planning for Phase 2.

UCF Answer: Yet to be determined for both a and b.

UCF Answer: Prioritized use cases and requirements Phase 3 will be determined at the time of its planning and kickoff.

33. Vendor Question: Will UCF clarify if there are any page restrictions for submission of the ITN response?

UCF Answer: None.

34. Vendor Question: Section 2.15 State Licensing Requirements: Will UCF confirm that proof of state licensing will not be required until notification of award?

UCF Answer: The awarded supplier shall have all appropriate licenses to conduct business in the State of Florida and Orange County at or prior to award of a contract.

35. Vendor Question: Section 2.57 Employee Background Checks: Will UCF confirm that the required background checks are not required until after notification of award?

UCF Answer: Correct.

Will UCF consider removing the language here that requires the references to come from projects that the proposed staff were directly involved in, or clarify the intention?

UCF Answer: The intention is to see what kind of experience the proposed team has in relation to the requirements.

37. Vendor Question: Section 3.2.A.2: "Provide a list of current or very recent similar-type client references, if any, which are in the United States and in higher education." The ITN requests references for work performed within the U.S. and the higher education industry; will UCF additionally consider references from non-higher education clients?

UCF Answer: Please see the answer to question #20

Vendor Question: Section 3.2.A.3: "Provide project descriptions for up to five (5) recent projects similar in scope and size to the proposed project in education (or similar public/government entity)..." The ITN requests recent project descriptions for higher education and/or similar public/government entities; will UCF additionally consider recent projects from commercial (non-public/government) clients?

UCF Answer: Our expectation is to review names and resumes for all proposed team members.

40. Vendor Question: Section 3.2.D: Overall Pricing -and-Section 4.1: Implementation Phases and Timeline. It is somewhat unclear if the expectation is for fixed price for Phase 1 followed by additional negotiation for Phases 2 and 3 based on discovery during Phase 1. Will UCF clarify the Phase 1, 2, and 3 timeline and expectations for the pricing schedule outlined in Sections 3.2.D and Appendix A?

UCF Answer: The clarification is fixed price for Phase 1, 2, and 3 for the proposal submission.

41. Vendor Question: Section 4.1: Phase 1, "a. Implement and stand-up a secured Data Lake/Warehouse environment within Microsoft Azure that is fully integrated with UCF data governance, identity management and security requirements by the end of January 2022."

a. Will UCF clarify if the January 2022 date is a mandatory requirement, and what business objectives or constraints are driving this date?

UCF Answer: We are still targeting January 2022, but are open to slight adjustment based upon project discovery and planning. The timelines are guided by Workday implementation project planned go-live date.

b. If the Phase 1 complete date is not flexible, does UCF acknowledge that a larger delivery team may be needed to meet the timeline?

UCF Answer: Yes.

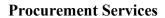

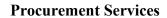

UCF Answer: Appendix A cannot be modified to exclude the original line items but clarification can be added as well as additional line items which the supplier believes will be needed for a successful implementation.

UCF Answer: Mark the HECVAT as confidential and in the case of a public records request, we will notify the respondent and work to redact what is permissible per FL Statute prior to releasing records.

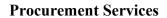

UCF Answer: Appendix A is to provide total amounts for the various services. Billing rates to be provided for the different roles of personnel to be part of the team along with total hours.

UCF Answer: Data is stored On Prem in various applications.

56. Vendor Question: Do you currently have an existing ETL tool that you use for data ingestion?

UCF Answer: Yes.

57. Vendor Question: What data quality/metadata management tools are available? Do we have any data quality rules and cleansing incorporated already?

UCF Answer: No meta-data management tool is used. DQ rules would be developed per data use case

UCF Answer: SFTP and other methods

UCF Answer: Beyond the ITN, additional considerations are still developing.

UCF Answer: Yes, this is the primary focus of Phase 1.

UCF Answer: To be determined based on use case.

72. Vendor Question: How much change management will you require throughout the implementation of the project? (ex: communications plans, end-user training, rollout strategy)

UCF Answer: Change management is performed in-house. Please also see response to question #46.

73. Vendor Question: What are your requirements and existing protocols for data security and access control?

UCF Answer: To be provided during project discovery and planning.

74. Vendor Question: Is there any PII involved? If so, are there any tools already in use for the masking of PII?

UCF Answer: Potentially. Not aware of any masking tools outside of the ERP.

75. Vendor Question: Do already have a data governance framework in place or should it be proposed by the vendor? (ex: Data lifecycle, lineage, monitoring, stewardship)

76. Vendor Question: Are any MDM domains (ex: customer) that need to be mastered?

UCF Answer: MDM is not in-scope for this project.

UCF Answer: No, not at this time.



78. Vendor Question: Will you expect a security mechanism as part of the dashboards? If so, at which level do you expect to implement such security (ex: project folder level, report level, data level security?)

UCF Answer: There will be some level, but structure is unknown at this time.

79. Vendor Question: How many internal users would you expect as an audience for this dashboard? What types of user personas? I.e. Students, faculty, etc.

UCF Answer: Please see answer to question #15.

80. Vendor Question: What is the main reporting tool (if any) that is utilized by UCF? If none, do you have an initial preference for anyone reporting tool?

UCF Answer: We use multiple tools: e.g. PowerBI, Tableau, SAS, Excel, SAS Visual Analytics

81. Vendor Question: How many reports do you actively maintain and wish to migrate to the unified reporting platform determined via this engagement?

UCF Answer: We maintain many reports across many systems and will migrate reports as needed.

82. Vendor Question: Will end users need to access this application from a mobile/tablet device? Or just desktop?

UCF Answer: Anticipate needing multiple ways to access the environment.

83. Vendor Question: Will you want to push for self-service reporting analytics at UCF or will you want IT to develop and vet all reports made available to your audiences?

UCF Answer: We are a heavy self-service reporting environment with multiple units that have the ability to create and deliver reporting. However, data access security and report governance will be part of this process.

84. Vendor Question: Are there any reports that you will be seeking to make public? (ex: embedded in the UCF website). Or are you keeping reports to be serviced by Azure Cloud environment internal?

UCF Answer: Yes, some reports will be publicly available.



85. Vendor Question: What percentage of your reports would you say are paginated reports?

UCF Answer: Unknown at this time

86. Vendor Question: Are there any advanced reporting functionalities that you know you'd like to include as part of your future state reporting solution? If so, which ones?

UCF Answer: Richer use of predictive analytics and deep learning in the future.

87. Vendor Question: As we understand, all data should be stored within the Data Lake / Warehouse? or can alternate storage solutions exist to support the solution be more efficient and optimized?

UCF Answer: All historical PS data that has been identified as mission critical for Phase 1, and data identified for subsequent phases will reside in the Data Lake/Warehouse solution.

88. Vendor Question: Currently, what is the process to ingest data from the historical PeopleSoft (PS) data?

UCF Answer: Direct query or internal PeopleSoft reports and queries

89. Vendor Question: Has the current data found in PeopleSoft (PS) been transferred to a data warehouse solution already? If so, which tools were used? Within Azure?
