Where necessary to make the language of the FAR, DFARS, and NFS clauses applicable, the term "Contractor" shall mean "Subcontractor," "Seller," or "Supplier;" the term "Contract" or "Subcontract" shall mean "Purchase Order;" the term "Government" shall mean "Buyer" or "UCF;" and the term "Contracting Officer" shall mean "Buyer's Purchasing Representative."
