

UNIVERSITY OF CENTRAL FLORIDA
GENERAL PROVISIONS AND CERTIFICATIONS FOR GOVERNMENT CONTRACTS

For all solicitations, contracts, and/or purchase orders (collectively “Orders”) paid in whole or in part with funds obtained from the federal government, the following provisions from the Federal Acquisition Regulation (“FAR”), the Defense Federal Acquisition Regulation Supplement (“DFARS”), and the NASA Federal Acquisition Regulation Supplement (“NFS”) are hereby incorporated by reference where applicable with the same force and effect as if set forth in full text. The full text of the FAR clauses may be found at <https://www.acquisition.gov>, the full text of the DFARS may be found at <https://www.acquisition.gov/dfars>, and the full text of the NFS may be found at <https://www.acquisition.gov/nfs>. Supplier agrees to flow down all applicable FAR, DFARS, and NFS clauses to lower tier subcontractors.

Where necessary to make the language of the FAR, DFARS, and NFS clauses applicable, the term “Contractor” shall mean “Subcontractor,” “Seller,” or “Supplier;” the term “Contract” or “Subcontract” shall mean “Purchase Order;” the term “Government” shall mean “Buyer” or “UCF;” and the term “Contracting Officer” shall mean “Buyer’s Purchasing Representative.”
